

Bookings

Bookings can be made by post, email or online and are regarded as confirmed bookings when made. An online booking form can be accessed at www.ukla.org.uk/events.

Telephone bookings should be confirmed in writing within 10 days.

All bookings will only be regarded as provisional until we have received payment in full. Where discount is given for early bird booking the booking must be paid for in full within the early bird window.

Cancellations

Written notification of cancellation of the event/course course booking within 0-30 days (inclusive) of the course date, or failure to attend a course or event without prior written notification, will be subject to the scale of charges shown in the Transfer and Cancellation table below. The full course fee is due 30 days prior to the course date:

- 1. For training courses, the start date is the date the course begins
- 2. For events and seminars, it is the day of the course

Courses booked inside 30 days must be paid immediately.

Substitutions

Clients may substitute the original delegate with another person at no extra charge. Written notification is required to substitute a delegate.

Transfers

Transfers will only be accepted at the discretion of UKLA. For transfer requests please contact the Secretariat on 01442 875922.

Cancellation Charges

15-30 days 100% of fee due

1-14 days 100% of fee due

(The original course fee is the amount that has been invoiced, i.e. this may show a discount if the attendee has booked an early bird rate).

All late bookings, first confirmed within 30 days of the course date, will be subject to normal cancellation and transfer terms and conditions. Entry to the course will be denied if payment has not been received or prior written agreement has not been given.



Payment

All event and course fees must be paid in full no later than 30 days prior to the start of the course or immediately for late bookings.

Settlement of the invoice is only deemed to have happened when the full amount has been paid and cleared. The United Kingdom Lubricants Association reserves the right to levy interest or administration charges in the event of payments being made by instalments. This should be agreed in writing in advance; default on a payment due will result in the full balance becoming payable and possible removal from the course.

Accommodation and transport

Where a course is defined as residential (for example the Executive Briefing), this will include accommodation from the evening of the first day of the course to the final afternoon of the course (unless otherwise stated on the booking confirmation), on a single occupancy basis.

Extended accommodation arrangements should be arranged directly with the hotel and are chargeable to the individual delegate and/or their organisation.

Cancellation of course

The United Kingdom Lubricants Association reserves the right to amend or cancel any event, course, course times, dates or published prices.

Changes to event or course prices, times and dates will be advised before the event or course start date and any event or course already paid in full will not be subject to the increased price.
