BUILD YOUR FUTURE WORKFORCE AND SHAPE THE LIVES OF YOUNG PEOPLE

The Youth Guarantee is the government’s commitment to ensure that every young person aged 16 to 24 has the support and opportunities to get into work or education.

Over the next three years, the government will **invest £2.5 billion to help young people** build skills, gain experience and progress into employment or further learning. This investment will support almost one million young people and **unlock up to 500,000 jobs, training and learning opportunities**.

For employers, the **Youth Guarantee offers access to fully funded training, financial incentives and a pipeline of young talent**. This support is designed to help you fill skills gaps today while investing in your future workforce.

How can you be part of the Youth Guarantee?

Be part of the Youth Guarantee by:	Government’s offer of support
Recruiting more young people into jobs or apprenticeships	• Apprenticeships: We are fully funding apprenticeships training for eligible 16–24-year-olds at non-levy paying employers from the next academic year, expanding foundation apprenticeships and introducing short courses to help businesses develop the skills they need in England. This builds on increased flexibility for employers, including reducing the apprenticeship minimum duration to 8 months, and making English and maths requirements more flexible for adult apprentices. • Apprenticeship incentives: A new £2,000 incentive for non-levy payers in England, recruiting a young person aged 16-24, delivered from October 2026. Employers could receive further incentives, including £1,000 for recruiting apprentices under 19-, or 19–24-year-olds with an EHCP or have been, or are in care, and £2,000 for eligible foundation apprenticeships. • Youth Jobs Grant: Employer incentive worth £3,000 to employers who recruit young people aged 18-24 across GB who have been on UC for six months, delivered from June 2026.

- **Jobs Guarantee:** The [Jobs Guarantee](#) will guarantee a six-month paid job for up to 25 hours a week, at minimum wage for every eligible 18-24-year-old who has been on Universal Credit (UC) and looking for work for 18 months, **with the government covering 100% of employment costs**. We are rolling out 1,200 places in Spring 2026, with a full rollout of nearly 90,000 places from Autumn 2026.
- **Employer NICs relief:** In most cases, **employers automatically pay no employer National Insurance (NI) Contributions** for employees [under 21](#) and are **not required to pay NI for apprentices under 25** (for wages below £50,270 a year).

Working with DWP to create more work experience placements and training places for young people

For young people on UC in Great Britain who are looking for work we are:

- Creating up to **150,000 additional work experience placements**.
- Creating up to **145,000 bespoke training opportunities** designed in partnership with employers, through our existing [Sector-Based Work Academy Programmes](#) (SWAP)

Partnering with Skills England to develop tailored sector skills packages

- We have invested over **£1 billion in skills packages** to strengthen talent pipeline into high-demand jobs in construction, digital and AI, engineering, and defence in England. Skills England will **develop tailored sector skills packages in partnership with industry and government**, supporting the development and implementation of [sector-led Job Plans](#).

Partnering with DWP to set up and/or provide services within a Youth Hub

- We are **expanding Youth Hubs to over 360 locations across Great Britain** so that all young people – including those not on benefits – can access opportunities and wider support in their local area. These hubs will help match local employers with local talent and we welcome partners to increase hubs from current c. 100 to over 360.

Accessing DWP's 'employer commitment'

Employers benefit from a **tailored recruitment service to help fill vacancies** with Jobcentre candidates. This includes:

- Support with job descriptions and speeding up recruitment and promotion of vacancies locally and online.
- Use of Jobcentre space for interviews and invitations to recruitment events.
